

DATA PROTECTION

Protecting your personal information is important to us. Below we inform you that Landhotel MontfortSchlössle ("We") how we collect, process and use your personal information in conjunction with our website at the URL <http://www.montfort-schloessle.de> ("Website") (in summary referred to as "use"). No permission through usage

The decisive factor for the use of your information is the respective applicable provisions, particularly the Federal Data Protection law and the Telemedia Law. If we*

use data for a purpose that requires your permission according to these provisions, we will ask for your explicit permission in each case. We can revoke permission previously given at any time with future effect and/or object to the future usage of your information. Merely using our website or acknowledging these data protection instructions does not replace your explicit declaration of intent.

Usage of your data

We use your personal information which may be collected as part of your use of the website for the use of the website and to execute and bill your reservations and also pass this information on to third parties for this purpose which we involve in the execution of the order, e.g. shipping companies.

When you access our website, technical information such as the type of web browser, the operating system used, the domain name of your Internet service provider and similar information is recorded, which we access for the technical handling of website usage and statistically assess this information. However, this information does not make it possible to conclude your identity.

If you would like to use personalised services on our website such as the booking function, you also have to register. The data that you create or enter here such as name, address, contact and communication data (such as phone number and e-mail address) and if necessary payment information as well as other data which may be collected from you during registration or the usage of our website or in communication with us or which you transmit in another way, e.g. my e-mail or by phone, are used by us to process your reservations and for communication with you.

If you voluntarily provide further information on your identity, such as your areas of interest, we will use this information if necessary to send you information on other offers. Whether and in which form this occurs depends on the relevant statutory provisions in which form the data are transferred and whether you have accepted or rejected a certain form of contact.

Thus, you can object to the use of your e-mail address as a means of sending advertising through e-mail at any time without additional charges. You can object to the use of your

information for advertising or marketing or opinion research purposes at any time without additional charges.

You can find out how to do this in the Rights section.

Otherwise, your personal information is processed and used only in accordance with German data protection law.

Saving and processing your data

Your personal information is stored by us on a server in Germany. Our servers are secured with firewalls and virus protection.

Cookies

Cookies are files that are placed on the hard disk of your computer and which our server accesses with each visit to our website. We use cookies in order to make your use of the website more convenient. You can prevent or limit your computer from saving cookies on your hard drive by setting your browser in such a way that it does not accept any cookies or you are asked if you agree before any cookies are placed on your computer. You can delete any cookies which are placed at any time. You can see how this works in your browser's operating manual. If you do not accept cookies, this can result in restrictions in the use of our service.

In addition, we use cookies if necessary to create usage profiles on the use of our website under a pseudonym (which is not combined with data on your identity), which we assess for advertising, market research and the improvement of our services if you have not asserted your legal right to object to the usage of your information. You can find out how to do this in the Rights section. Alternatively, as described above, you can deactivate the use of cookies.

Use of Google Analytics

This website uses Google Analytics, a web analysis service of Google Inc. ("Google"). Google Analytics uses what is known as "cookies", text files which are saved on your computer and which allow an analysis of the website usage. Information created by the cookie on your use of this website are usually transferred to a Google server in the US and stored there. IP anonymisation was activated on this website so that the user's IP address will be abbreviated in advance within member states of the European Union or in other contractual states of the Treaty on the European economic region.
